> PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON EASTON BOULEVARD RESURFACING FROM HUBBELL AVENUE TO E. 33RD STREET; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS GRIMES ASPHALT AND PAVING CORPORATION, TIMOTHY MALLICOAT, PRESIDENT, \$515,942.10

WHEREAS, on March 23, 2020, under Roll Call No. 20-0503, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

Easton Boulevard Resurfacing from Hubbell Avenue to E. 33rd Street, 06-2020-004

The improvement includes pavement scarification, Hot Mix Asphalt (HMA) overlay, Portland Cement Concrete (PCC) sidewalk, storm sewer, storm sewer intakes, PCC median, pavement markings, and other incidental items; in accordance with the contract documents, including Plans File Nos. 616-169/199, on Easton Boulevard from Hubbell Avenue to E. 33rd Street, Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.
