## SET HEARING FOR APPROVAL OF DOCUMENTS FOR CONVEYANCE OF VACATED ALLEY RIGHT-OF-WAY LOCATED WEST OF AND ADJOINING 215 WATROUS AVENUE TO LATEKA M. WRIGHT FOR \$50.00

WHEREAS, on September 16, 1996, by Ordinance No. 13,376, the City Council of the City of Des Moines, Iowa vacated the north-south alley right-of-way lying west of and adjoining 215 Watrous Avenue; and

**WHEREAS**, Lateka M. Wright, owner of 215 Watrous Avenue, has offered to the City of Des Moines ("City") the purchase price of \$50.00 for the purchase of the portion of vacated alley right-of-way lying west of and adjoining the north 76 feet of her property at 215 Watrous Avenue (hereinafter "Property"), for assemblage with her residential parcel, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated, which price reflects the fair market value of the City Property as determined by the City's Real Estate Division; and


WHEREAS, there is no known current or future public need or benefit for the City Property proposed to be sold, and the City will not be inconvenienced by the sale of said Property.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, as follows:

1. The City Council of the City of Des Moines, Iowa, proposes to sell the vacated alley right-of-way lying west of and adjoining the north 76 feet of 215 Watrous Avenue, as legally described, to the grantee, and for the consideration identified below, subject to a reservation of easements therein:

Grantee: Lateka M. Wright Consideration: \$50.00 Legal Description: ALL OF THE VACATED ALLEY RIGHT OF WAY LYING WEST OF AND ADJOINING THE SOUTH 76 FEET OF LOT 42, DEVIN PLACE ADDITION, AN OFFICIAL PLAT, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA, AND CONTAINING APPROXIMATELY 988 SQUARE FEET.

2. A public hearing shall be held on June 22, 2020, at 5:00 p.m. Given Mayor Cownie's March 17, 2020 Proclamation Amendment prohibiting gatherings of ten or more persons on public property and the Section One of the Governor's May 26, 2020 Proclamation strongly encouraging vulnerable Iowans to limit participation in gatherings of any size and any purpose during the COVID19 outbreak and further given Section One Thirty Nine of the Governor's May 26, 2020 Proclamation suspending the regulatory provisions of Iowa Code §§ 21.8, 26.12, and 414.12, or any other statute imposing a requirement to hold a public meeting or hearing, the City Council has determined that a meeting at a physical place is impossible or impracticable and all Council meetings for the time being will be conducted electronically with the public allowed to attend per the instructions below. 
