RESOLUTION SETTING HEARING ON THE CITY-INITIATED REQUEST FOR DESIGNATION OF THE DRAKE PARK PLAYGROUND SHELTER, 2300 DRAKE PARK AVENUE, DES MOINES, IOWA, AS A LOCAL LANDMARK

WHEREAS, the City of Des Moines has pending an application to designate the Drake Park Playground Shelter, located on property at 2300 Drake Park Avenue, Des Moines, Iowa, as a local landmark; and

WHEREAS, on May 5, 2020, the Landmark Review Board unanimously approved the recommendation that the "Drake Park Playground Shelter" be designated a local Landmark; and

WHEREAS, on May 21, 2020, the Plan and Zoning Commission, by a vote of 12-0, recommended to the Council APPROVAL of the application; and

WHEREAS, the Des Moines Municipal Code Section 58-60 requires a public hearing be held to consider the application.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. That the attached communication from the Plan and Zoning Commission is hereby received and filed.
2. That the City Council consider approving the application for the designation of the Drake Park Playground Shelter as a local landmark at a hearing to be held at 5:00 p.m. on June 22, 2020, by electronic means in accordance with the Governor's and Mayor's Proclamations and to encourage and maintain social distancing to curb the spread of COVID19 in the community, with or without public access to the meeting location, at which time the City Council will hear both those who oppose and those who favor the proposal.
3. That the City Clerk is hereby authorized and directed to cause notice of said proposal in the accompanying form to be given by publication once, not less than seven (7) days and not more than twenty (20) days before the date of hearing, all as required in Iowa Codes Sections 362.3 and Section 386.3(4).
4. That notice referred to above shall be in the form attached hereto as Exhibit "A", which contains information required by Iowa Code Section 386.4(5).
