APPROVING EXECUTION OF A COOPERATIVE AGREEMENT BETWEEN THE CITY OF DES MOINES, IOWA, AND THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD)

WHEREAS, on September 8, 1987, by Roll Call No. 87-3813, the Des Moines City Council authorized the Des Moines Human Rights Commission to execute a Memorandum of Understanding with HUD, setting forth the terms and conditions by which the Commission processes housing discrimination complaints arising within the city limits of Des Moines, Iowa, in accordance with HUD's Fair Housing Assistance Program, and sends staff to mandatory training as required by HUD; and

WHEREAS, the City Council has approved similar agreements on an annual basis; and

WHEREAS, this Cooperative Agreement for fiscal year 2020 provides \$39,300.00 for complaint processing, \$12,500.00 for administrative costs, and \$8,800.00 in training funds for a total funding award of \$60,600.00 for use by the Des Moines Civil and Human Rights Commission in accordance with the cooperative agreement terms;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Cooperative Agreement for FY2020 and amendments thereto up to 25% of this grant amount between the United States Department of Housing and Urban Development (HUD) and the City of Des Moines are hereby approved, and the Mayor is hereby authorized and directed to execute the Cooperative Agreement, including amendments which may provide up to 25% of this grant in additional funding to the Des Moines Civil and Human Rights Commission, on behalf of the City of Des Moines

BE IT FURTHER RESOLVED that the Des Moines Human Rights Commission Director is hereby authorized and directed to submit the Cooperative Agreement, and the authorized amendments thereto for additional funding, to the HUD Fair Housing Assistance Program and to complete and submit any additional documents associated therewith.
