RESOLUTION SETTING DATE OF PUBLIC HEARING ON THE PROPOSED FIRST AMENDMENT TO THE URBAN RENEWAL PLAN FOR THE 38TH AND GRAND URBAN RENEWAL AREA

WHEREAS, on November 4, 2019, by Roll Call No. 19-1768, the City Council approved the 38th and Grand Urban Renewal Plan (the "Urban Renewal Plan") which seeks to enhance private development within the 38th and Grand Urban Renewal Area though provision of infrastructure improvements and economic development assistance that will be provided in part with tax increment financing revenues to be generated in the urban renewal area; and,

WHEREAS, the 38th and Grand Urban Renewal Area is generally located generally located along the Grand Avenue corridor between 31st Street and 42nd Street.; and,

WHEREAS, the City Council desires to consider a proposed First Amendment to the Urban Renewal Plan to amend the Urban Renewal Area to:

- Update the Financial Condition Report incorporated in Exhibit C to reflect the new projects and material amendments to existing projects.
- Amend and update Appendix D-Approved Public Improvement Projects to reflect updates to the Capital Improvement Plan funded with tax increment revenues from the 38th and Grand Urban Renewal Area.

WHEREAS, a copy of the proposed First Amendment is on file and available for public inspection in the office of the City Clerk; and,

WHEREAS, the Urban Design Review Board is schedule to review the proposed First Amendment at its regular meeting on and should be prepared to submit its report and recommendation to the City Council before the date proposed for public hearing by the City Council.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. A public hearing shall be held before the City Council to consider the proposed First Amendment to the 38th and Grand Urban Renewal Plan at 5:00 p.m. on November 6, 2020, in the City Council Chambers at City Hall.
- 2. The City Clerk is authorized and directed to publish notice of said public hearing in the accompanying form in the Des Moines Register on October 23, 2020.

The consultation meeting shall be held prior to the date of public hearing at a time and location to be determined by the Director in accordance with Iowa Code §403.5(2). The Director shall cause notice of the consultation meeting, a copy of the Notice of Public Hearing, and a copy of the proposed First Amendment to be mailed to each such affected taxing entity.
