## PUBLIC HEARING FOR APPROVAL OF THE PROPOSED 2021 ACTION PLAN AS PART OF THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) 2020-2024 CONSOLIDATED PLAN

WHEREAS, provisions under Code of Federal Regulations (CFR) Chapter 24, Section 91.220 regarding Annual Action Plans for the Consolidated Plan for HUD grant programs require the City to submit an annual action plan for the 2021 Program Year to the United States Department of Housing and Urban Development (HUD) no later than 45 days prior to start of the 2021 Consolidated Plan Program Year; and

**WHEREAS,** the City Council must conduct a public hearing to review the proposed activities within the 2021 Action Plan and receive citizen comments regarding those activities, and provide notice of the hearing to be published at least thirty days before it is held; and

**WHEREAS**, on September 14, 2020, by Roll Call No. 20-1445, the City Council set a public hearing for November 9, 2020 at 5:00 p.m. to obtain citizen comments regarding the 2021 Annual Action Plan as part of the 2020-2024 Consolidated Plan in compliance with the HUD regulations; and


**WHEREAS**, due notice of the public hearing was published in the Des Moines Register on October 2, 2020, and copies of the proposed 2021 Annual Action Plan were made available for public review on the City of Des Moines web site, dsm.city, to provide citizens with the opportunity to participate in the hearing; and

**WHEREAS**, the public hearing on this date has been opened and those seeking to comment on the 2021 Annual Action Plan have been afforded the opportunity to do so;

WHEREAS, HUD will forward three Grant Agreements for Community Development Block Grant (CDBG), HOME Investment Partnership Program (HOME), and Emergency Solutions Grant (ESG) funds once the Annual Action Plan has been received and approved for the program year running January 1, 2021 to December 31, 2021.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that:

- 1. All public comments regarding the 2021 Action Plan have been received and the hearing is hereby closed.
- 2. The 2021 Annual Action Plan, on file with the City Clerk and by this reference made a part hereof, is hereby approved.
- 3. The City Manager or his designee is hereby authorized and directed to submit the 2021 Annual Action Plan to the U.S. Department of Housing and Urban Development.
