APPROVING AMENDMENT FOR EXTENSION OF CONTRACT WITH THE ACTIVE NETWORK, INC. FOR ONLINE REGISTRATION, RESERVATION AND PAYMENT SERVICES AND AUTHORIZING EXECUTION OF AMENDMENT BY CITY MANAGER

WHEREAS, the City of Des Moines offers numerous athletic and recreational programs requiring registration and has numerous facilities which may be reserved for use by the general public; and

WHEREAS, the Parks and Recreation Department desires to offer the public the convenience of registering for programs and reserving facilities and paying for same online; and

WHEREAS, on August 6, 2012, a Request for Proposals V13-015 (the "RFP") for a comprehensive online park and recreation registration, reservation and payment system hosted by a vendor "On Line Registration for City of Des Moines Parks and Recreation Department" was issued by the City of Des Moines and two proposals were received; and

WHEREAS, on December 17, 2012, by Roll Call No. 12- 1945, the City Council approved and accepted the proposal submitted by The Active Network, Inc., a Delaware corporation, 10182 Telesis Court, Suite 100, San Diego, and approved a Contract with an initial term of three years and one three year renewal; and

WHEREAS, the Parks and Recreation Department desires to extend said Contract until up to June 30, 2022 in order to have adequate time to research the technical innovations for similar software registration, reservation and payment services systems and to develop a Request for Proposals, select a service provider and coordinate the transition to a new system; and

WHEREAS, an Amendment for Extension of Contract has been negotiated which would extend the agreement until up to June 30, 2022, a copy of which is on file in the City Clerk's Office.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the proposal Amendment for Extension of Contract with The Active Network, Inc., a copy of which is on file in the City Clerk's Office, is hereby approved and the City Manager is authorized and directed to execute such Contract for and on behalf of the City and the City Clerk is authorized to attest to his signature; and the City Manager is authorized and directed to provide notice of termination prior to June 30, 2023, if such termination may be necessary or beneficial to the operation of the Parks and Recreation Department programs and facilities.
