PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON 2021 TRAFFIC SIGNAL REPLACEMENT CONTRACT 1; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS IOWA SIGNAL, INC., WAYNE LESLEY, PRESIDENT, \$471,423.67

WHEREAS, on October 5, 2020, under Roll Call No. 20-1547, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

2021 Traffic Signal Replacement Contract 1, 042021008

The improvement includes new traffic signals, vehicle detector loops, Portland Cement Concrete (PCC) pavement, PCC sidewalks, pavement markings, modular block retaining wall, and other incidental items; all in accordance with the contract documents, including Plan File Nos. 619-245/281, located at the intersection of 56th Street and Grand Avenue and the intersection of 42nd Street and Grand Avenue, Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.
