SET HEARING FOR APPROVAL OF DOCUMENTS TO CORRECT THE VACATION OF A PORTION OF DES MOINES STREET RIGHT-OF-WAY LOCATED SOUTH OF AND ADJOINING 519 DES MOINES STREET

WHEREAS, on March 22, 2010, by Roll Call No. 10-452, the City Council of the City of Des Moines voted to pass Ordinance No. 14,925 vacating approximately 357.5 square feet of Des Moines Street right-of-way located north of and adjoining 519 Des Moines Street to allow for a sidewalk café lease; and

WHEREAS, subsequent to passing Ordinance No. 14,925 an error was discovered in the legal description of the vacated right-of-way leading to the need to repeal said ordinance and pass a new ordinance to vacate the properly described right-of-way.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

- 1. The City Council of the City of Des Moines, Iowa, shall consider adoption of a corrected ordinance permanently vacating a portion of Des Moines Street right-of-way located north of and adjoining 519 Des Moines Street, legally described as follows, subject to the reservation of easements for any existing utilities until such time that they are abandoned:
- -EXCEPT THE SUBSURFACE AREA BELOW GRADE-, THE SOUTH 6.5 FEET OF DES MOINES STREET RIGHT OF WAY LYING NORTH OF AND ADJOINING THE WEST 55.0 FEET OF THE EAST 65.0 FEET OF BLOCK 17, EAST FORT DES MOINES, AN OFFICIAL PLAT, ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA, AND CONTAINING APPROXIMATELY 357.5 SQUARE FEET.
- 2. That the meeting of the City Council at which the repeal of Ordinance No. 14,925 and the adoption of said corrected ordinance vacating such right-of-way is to be considered shall be on December 21, 2020, said meeting to be held at 5:00 p.m., in the City Council Chamber, Richard A. Clark Municipal Service Center, 1551 E. Martin Luther King Jr. Parkway, Des Moines, Iowa. Given Mayor Cownie's March 17, 2020 Proclamation, as amended, prohibiting indoor gatherings of ten or more persons on public property, Section One of the Governor's October 16, 2020 Proclamation strongly encouraging vulnerable Iowans to limit participation in gatherings of any size and any purpose during the COVID19 outbreak, and further given Section 109 of the Governor's October 16, 2020 Proclamation suspending the regulatory provisions of Iowa Code §§ 21.8, 26.12, and 414.12, or any other statute imposing a requirement to hold a public meeting or hearing, and further given the City Manager's decision to delay the opening of City buildings to the public due to the recent upwards spikes of positive COVID-19 cases and hospitalizations in Polk County and the need to maintain safety; it is impossible and impractical to have physical public access to the meeting location and the meeting will be conducted electronically with electronic public access to the meeting location as set
