SANITARY SEWER IMPROVEMENTS SET FORTH IN AND CONSTRUCTED  
PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, GROVER WOODS PLAT 1,  
BETWEEN MCANINCH CORPORATION AND HRC GROVER WOODS, LLC (2506C)

WHEREAS, on May 4, 2020 under Roll Call No. 20-0738, the City Council approved a private construction contract in the amount of \$173,854.00, between McAninch Corporation, Douglas D. McAninch, President/CEO, 4001 Delaware Avenue, Des Moines, IA, 50313 - as Contractor, and HRC Grover Woods, LLC (2506c), 6900 Westown Parkway, West Des Moines, IA - as Owner, for construction of Sanitary Sewer Improvements described as sanitary sewer improvements to serve Grover Woods Plat 1, as shown on Plan File Numbers 618-153/176, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Sanitary Sewer Improvements in the amount of \$173,854.00, which have been constructed in substantial compliance with the contract documents between McAninch Corporation and HRC Grover Woods, LLC (2506c), which were approved under Roll Call No. 20-0738, dated May 4, 2020, be received and filed; and that completion of said Sanitary Sewer Improvements described as sanitary sewer improvements to serve Grover Woods Plat 1, as shown on Plan File Numbers 618-153/176, is hereby acknowledged and that said Sanitary Sewer Improvements are hereby accepted.
