SETTING DATE OF HEARING ON AMENDMENT TO MUNICIPAL HOUSING AGENCY ANNUAL BUDGET FOR THE CURRENT FISCAL YEAR ENDING JUNE 30, 2021

Clark Municipal Services Center, Des Moines, Iowa, at which time any resident or taxpayer of the City or the area of operation of the Agency may present objections to any part of the proposed budget amendment and change or arguments in favor of any part of the proposed budget amendment or change.

The City Clerk is hereby authorized and directed to publish notice of the hearing in the attached form in the Des Moines Register, a newspaper of general circulation in the City of Des Moines, Polk County, Iowa, in accordance with Iowa Code Section 362.3 not less than ten (10) nor more than twenty (20) days prior to the date set for hearing.
