SET HEARING FOR APPROVAL OF DOCUMENTS FOR VACATION OF A SEGMENT OF SOUTHWEST 1ST STREET RIGHT-OF-WAY BETWEEN COLUMBUS AVENUE AND INDIANOLA ROAD AND CONVEYANCE TO MUNDO PEQUENITO, LLC FOR \$4,320

WHEREAS, on November 23, 2020, by Roll Call No. 20-1863, the City Council of the City of Des Moines, Iowa voted to receive and file a recommendation from the City Plan and Zoning Commission to approve a request from Mundo Pequenito, LLC to vacate the west six feet of Southwest 1st Street between Columbus Avenue and Indianola Road, subject to the reservation of easements for existing utilities in place until such time as they are abandoned or relocated at the expense of the City's successor in ownership of the vacated right-of-way; and

WHEREAS, Mundo Pequenito, LLC, the owner of 1922 Southwest 1st Street, has offered to the City of Des Moines, Iowa ("City") the purchase price of \$4,320 for the purchase of the west six feet of Southwest 1st Street right-of-way adjoining its property, subject to the reservation of easements for all existing utilities in place until such time that they are abandoned or relocated, which price reflects the fair market value of said portion of alley right-of-way as determined by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need for the portion of street right-of-way proposed to be vacated and sold, and the City will not be inconvenienced by the vacation and sale of said property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. That the City Council of the City of Des Moines, Iowa, shall consider adoption of an ordinance permanently vacating the six-foot wide strip of Southwest 1st Street right-of-way located east of and adjoining 1922 Southwest 1st Street, Des Moines, Iowa, legally described as follows, subject to the reservation of easements for all existing utilities in place until such time that they are abandoned or relocated:

THE WEST 6.0 FEET OF SOUTHWEST 1ST STREET LYING SOUTH OF THE SOUTH RIGHT OF WAY LINE OF COLUMBUS AVENUE AND LYING NORTH OF THE NORTH RIGHT OF WAY LINE OF INDIANOLA ROAD, ALL IN THE SOUTHEAST QUARTER (SE 1/4) OF SECTION 9, TOWNSHIP 78 NORTH, RANGE 24 WEST OF THE 5TH P.M., ALL NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA, AND CONTAINING APPROXIMATELY 0.03 ACRES (1,441 SQUARE FEET).

2. The City Council of the City of Des Moines, Iowa, further proposes to sell the vacated street right-of-way, as legally described below, to Mundo Pequenito, LLC for \$4,320, subject to reservation of easements therein:
