WHEREAS, following the respective public hearings on March 8, 2021, the Municipal Housing Governing Board approved the Municipal Housing Agency's amendment to annual budget for all projects for the current fiscal year ending June 30, 2021, by Roll Call No. 21- and approved the Municipal Housing Agency's proposed budget for all projects for the fiscal year ending June 30, 2022 by Roll Call No. 21- ; and

WHEREAS, the Des Moines Municipal Housing Agency is required to certify approval of the operating budgets to the U.S. Department of Housing and Urban Development.

NOW, THEREFORE, BE IT RESOLVED by the Municipal Housing Governing Board that the Mayor and City Clerk, as appropriate, are hereby authorized and directed to certify the Municipal Housing Agency's amended annual budget for all projects for the fiscal year ending June 30, 2021 and to certify the Municipal Housing Agency's proposed budget for all projects for the fiscal year ending June 30, 2022 on the forms on file in the Office of the City Clerk and the Community Development Director is hereby directed to submit such certifications to the U.S. Department of Housing and Urban Development.
