RECEIPT OF A CERTIFIED LOCAL GOVERNMENT (CLG) GRANT AWARD FROM THE STATE HISTORICAL SOCIETY OF IOWA TO THE CITY OF DES MOINES TO PARTIALLY FUND DEVELOPMENT OF A CITY-WIDE HISTORIC PRESERVATION PLAN AND AUTHORIZATION TO PROCEED WITH RFP FOR PROFESSIONAL SERVICES TO ASSIST WITH PLAN DEVELOPMENT.

WHEREAS, the City of Des Moines has been deemed a Certified Local Government (CLG) by the State Historical Society of Iowa; and,

WHEREAS, the State Historical Society of Iowa provides funding to CLG's for historic preservation projects and activities; and,

WHEREAS, the State Historical Society of Iowa (SHSI) solicited applications for CLG grants for Fiscal Year (FY) 2021; and,

WHEREAS, the City of Des Moines submitted an application for a 2021 CLG grant to be used for the proposed developed of a city-wide historic preservation plan; and,


WHEREAS, the SHSI has awarded the City of Des Moines a CLG grant in the amount of \$25,000 for the project to assist in the development of this plan; and

WHEREAS, the City will provide matching grant funding for the development of the plan, it is appropriate to proceed with procurement of professional services to assist in the project.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. That the Mayor is hereby authorized and directed to sign the CLG Grant-In-Aid Agreement from the State Historical Society of Iowa; and
- 2. That the City Manager is authorized to proceed with further steps to obtain professional services for assistance with this project, which may include but are not limited to development of an RFP for assistance with this project.
