RESOLUTION REDUCING SUBDIVISION IMPROVEMENT BOND FOR SOUTHWOODS ESTATES PLAT 1

WHEREAS, on June 14th, 2019, by Roll Call No. 19-0986, the City Council conditionally approved the final subdivision plat entitled Southwoods Estates Plat 1, for land located at 3800 SW 56th Street, to be developed by TK Land Development, LLC, 9550 Hickman Road, Clive, Iowa 50325, Dan Kruse, Manager, and also approved Subdivision Improvement Bond No. NIA2536 from Merchants Bonding Company, in the amount of \$115,348 as security for the estimated cost of sidewalk improvements; and,

WHEREAS, the City Engineer has certified that a portion of the required public sidewalk improvements have been satisfactorily completed and recommend that the security for such improvements be reduced to \$28,837.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. That Subdivision Improvement Bond No. NIA2536 in the amount of \$115,348 from TK Land Development, LLC and Merchants Bonding Company, is hereby released in part and reduced to an amount of \$28,837.00 as security for the satisfactory completion of the remaining subdivision improvements.
