PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON 2021 SANITARY AND STORM SEWER TELEVISING PROGRAM; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS EQUIX INTEGRITY, INC., MICHAEL DEBELAK, PRESIDENT, \$467,190.00

WHEREAS, on March 22, 2021, under Roll Call No. 21-0447, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

2021 Sanitary and Storm Sewer Televising Program, 072021001

The project includes the inspection and televising of approximately 10 miles (430,000 lineal feet) of sanitary sewer pipe ranging in size from 6-inch to 60-inch diameter utilizing Closed Circuit Televising (CCTV), including miscellaneous associated work and cleanup; all in accordance with the contract documents, located throughout the City of Des Moines, Iowa.

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

WHEREAS, in accordance with said notice, those interested in said proposed plans, specifications, form of contract documents, and Engineer's estimate of construction cost both for and against, have been given opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the upon due consideration of the facts, and any and all statements of interested persons, any objections to the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement are overruled and the hearing is closed and that said plans, specifications, form of contract documents, and Engineer's estimate of construction cost are here by approved.
