HOLD HEARING FOR CONSIDERATION OF APPROVAL OF A MEMORANDUM OF AGREEMENT AND LICENSE WITH THE UNITED STATES OF AMERICA, BY AND THROUGH THE GENERAL SERVICES ADMINISTRATION, FOR INSTALLATION AND MAINTENANCE OF CERTAIN IMPROVEMENTS ASSOCIATED WITH THE FEDERAL COURTHOUSE PROJECT AT 101 LOCUST STREET

WHEREAS, the United States of America, acting by and through the General Services Administration ("GSA") is the owner of the property locally known as 101 Locust Street upon which it is constructing a new federal courthouse; and

WHEREAS, the City of Des Moines owns and maintains the Grand Avenue right-of-way located north of and adjoining 101 Locust Street, Des Moines, Iowa ("Licensed Premises"); and

WHEREAS, GSA wishes to license the Licensed Premises for the purpose of installing and maintaining certain improvements associated with the federal courthouse including a site bench, four (4) trees and landscaping with associated irrigation, four (4) pedestrian light poles and bases, and four (4) area drains with associated piping, hereinafter sometimes referred to collectively as "improvements"; and

WHEREAS, the City will not be inconvenienced by the license of said Property; and

WHEREAS, on May 24, 2021 by Roll Call No. 21-0780, it was duly resolved by the City Council of the City of Des Moines, Iowa, that the proposed conveyance be set down for hearing on June 14, 2021, at 5:00 p.m., in the City Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa; and; and

WHEREAS, due notice of said proposal to enter into a Memorandum of Agreement and License with the United States of America, acting by and through the General Services Administration was given to all necessary parties as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed agreement, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed Memorandum of Agreement and License by and between City of Des Moines and the United States of America, acting by and through the General Services Administration, of a portion of the Grand Avenue right-of-way adjoining 101 Locust Street, Des Moines, Iowa, are hereby overruled and the hearing is closed.

The Real Estate Division Manager is authorized and directed to forward the original of the Memorandum of Agreement and License, together with a certified copy of this resolution and of the affidavit of publication of the notice of this hearing, to the Polk County Recorder's Office for the purpose of causing these documents to be recorded.

7. Upon receipt of the recorded documents back from the Polk County Recorder, the Real Estate Division Manager shall mail the original of the Memorandum of Agreement and License, and a copy of the other documents to the GSA.
