## **RESOLUTION SETTING DATE OF PUBLIC HEARING ON THE APPLICATION FOR VOLUNTARY ANNEXATION BY ILEX GROUP, INC.**

WHEREAS, on June 22, 2021, ILEX Group, Inc filed an amended application for voluntary annexation, including the following-described property:

THE WEST 125.71 FEET OF THE EAST 241.71 FEET OF THE NORTH 183.71 FEET OF THE SOUTH 241.71 FEET OF THE SOUTHEAST 1/4 OF THE SOUTHEAST 1/4 OF SECTION 14 TOWNSHIP 79 NORTH, RANGE 24 WEST OF THE 5TH P.M., POLK COUNTY, IOWA.

and

THE WEST 41 FEET OF THE EAST 116 FEET OF THE SOUTH 1/2 OF THE SOUTHEAST 1/4 OF THE SOUTHEAST 1/4 OF SECTION 14, EXCEPT THE SOUTH 241.71 FEET THEREOF, TOWNSHIP 79 NORTH, RANGE 24 WEST OF THE 5TH P.M., POLK COUNTY, IOWA.

This parcel contains approximately .94 acres and is shown on the maps attached as Exhibit A; and,

WHEREAS, on June 21, 2021, the City held a consultation meeting, with prior notice to Polk County and Saylor Township as required by Iowa Code section 368.7; and,


WHEREAS, the City Council of Des Moines must provide notice and hold a public hearing on the Application.
