135-9.2.3.B.14, 135-9.3.6.D, and 135-11.2.1.A of Chapter 135 of the Des Moines Municipal Code, Planning and Design Ordinance, to protect and preserve the rights, privileges, and property of the City of Des Moines and of its residents, and to preserve and improve the peace, safety, health, welfare, comfort and convenience of its residents",
