RESOLUTION APPROVING DES MOINES METROPOLITAN PLANNING ORGANIZATION FISCAL YEAR 2022 UNIFIED PLANNING WORK PROGRAM AND BUDGET AND FISCAL YEAR 2022 ASSESSMENT

WHEREAS, the City of Des Moines is a member of the Des Moines Area Metropolitan Planning Organization ("MPO"), as organized under Iowa Code Chapter 28E; and

WHEREAS, the MPO annually requests its member governments to approve, by resolution, the MPO's Unified Planning Work Program and budget for the upcoming fiscal year; and

WHEREAS, the budget to support the Unified Planning Work Program is funded with federal funds and member governments on a per capita basis, and the assessment rate of MPO member governments for Fiscal Year 2022 is set at \$1.00 per capita and when applied to the estimated Census population (estimated 214,237 Census population), equates to an assessment of \$214,237.00 to the City of Des Moines; and

WHEREAS, at least a majority of the Des Moines Area Metropolitan Planning Organization's member governments must approve the Unified Planning Work Program and budget; and

WHEREAS, the City Manager has recommended that the Unified Planning Work Program and budget submitted by the MPO for Fiscal Year 2022 be approved.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Des Moines Area Metropolitan Planning Organization's Unified Planning Work Program and budget for Fiscal Year 2022, beginning July 1, 2021, is hereby approved, and the Finance Department is hereby authorized and directed to pay the City's assessment of \$214,237.00 to the MPO when due.
