ACCEPTING PROPOSAL OF PUBLIC WORKS LLC TO PROVIDE PROFESSIONAL SERVICES IDENTIFYING BEST PRACTICES FOR RESEARCH AND DATA COLLECTION METHODS FOR CITY ORDINANCE ENFORCEMENT AND LAW ENFORCEMENT; AND APPROVING AND AUTHORIZING CITY MANAGER TO EXECUTE THE PSA AGREEMENT WITH PUBLIC WORKS LLC, FOR A TOTAL COST NOT TO EXCEED \$84,925

WHEREAS, On March 9, 2020, the City Council passed a resolution directing the City Manager to develop an RFP to determine best practices for research and data collection methods concerning law and code enforcement and to authorize implementation of such research and data collection; and

WHEREAS, In the Council Resolution, the City Council declared that it desires that all City employees act in a manner that is devoid of any type of discrimination; and, wishes to determine the best practices nationwide for collecting data and creating metrics to have valid review and study of internal trends and comparisons to improve City staff performance in fairly and impartially providing City services and determines that soliciting a RFP is an appropriate use of City resources to accomplish such objectives; and

WHEREAS, the City Manager's Office requested the Finance Department Procurement Division to solicit proposals for the research and data collection professional services and the Procurement Division solicited bids for such services by advertisement and mailing RFP No. N21-02 for Consulting Services for Best Practices and Data Collection Methods to 12 potential proposers with 2 proposals received; and

WHEREAS, the Evaluation and Selection Committee determined that the proposal submitted by Public Works LLC, a corporation registered in the state of Pennsylvania, with a business address of 1690 East Strasburg Road, West Chester, PA 19380, was the highest scoring proposal and recommends such proposal to the City Council for award of contract; and

WHEREAS, an agreement to provide such services has been negotiated by the City Manager's Office with Public Works LLC at a cost not to exceed \$84,925 with an option for implementation with the Consultant by adding to this agreement or under separate agreement, if the cost, efficacy, and effectiveness of the identified methods of research and data collection are satisfactory; a copy of which is on file in the City Clerk's Office.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the proposal submitted by Public Works LLC, for Consulting Services identifying best practices for research and data collection methods for city ordinance enforcement and law enforcement is hereby accepted and the City Manager is hereby authorized and directed to execute the negotiated agreement with Public Works LLC, at a cost not to exceed \$84,925 and evaluate,
