PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON DEMOLITION OF DICO BUILDINGS AT 200 SW 16TH STREET; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS EARTH SERVICES & ABATEMENT, LLC DBA IOWA DEMOLITION, KRISTIAN MITCHELL, CO-PRESIDENT, \$731,894.00

WHEREAS, on June 14, 2021, under Roll Call No. 21-0835, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

Demolition of DICO Buildings at 200 SW 16th Street, 252021041

The work includes removal and disposal of asbestos containing materials, disposal of hazardous and non-hazardous materials, demolition of designated structures and two above ground storage tanks, Hot Mix Asphalt, fencing, and traffic control; all in accordance with the contract documents, including Plan File Nos. 629-198/206, located on the former DICO property at 200 SW 16th Street, Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.
