WHEREAS, the Fleet Services Division has requested the Finance Department's Procurement Division issue a purchase order for three (3) conventional cab heavy duty truck replacements with dump bodies and snowplows for use by the Street Cleaning and Sewers Divisions of the Department of Public Works; and

WHEREAS, the equipment, which has been approved by the Fleet Oversight Committee (FOC), is being procured through the competitive bid process using Sourcewell Purchasing Contracts #060920-MAK and #080818-HPI; and

WHEREAS, Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the three (3) conventional cab heavy truck chassis with biodiesel dual fuel technology are being purchased from Housby Mack Inc., 4747 NE 14th Street, Des Moines, IA 50313 (Kelly Housby, CEO), in the amount of \$370,028.00 and the dump bodies and snow plow equipment are being purchased from and installed by Henderson Products Inc., 916 South 10th Street, Manchester, IA 52057, (John Sievert, President), in the amount of \$313,141.00.

WHEREAS, funding is available from the 2021-2022 Operating Budget, Equipment Replacement Fund, Page 83.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, accepts and approves the purchase of three (3) conventional cab heavy duty truck replacements with dump bodies and snowplows from Housby Mack Inc. and Henderson Products, Inc. using Sourcewell Purchasing Contracts #060920-MAK and #080818-HPI for a total amount of \$683,169.00.
