RESOLUTION WITH RESPECT TO PUBLIC HEARING ON THE ISSUANCE OF NOT TO EXCEED \$1,000,000 GENERAL OBLIGATION BONDS FOR GENERAL CORPORATE PURPOSES (GCP-3)

WHEREAS, pursuant to Section 384.26 of the City Code of Iowa, notice of the hearing on the issuance of not to exceed \$1,000,000 General Obligation Bonds and the proposed action by the City Council to institute proceedings for the issuance of said Bonds has been given for the purpose of paying costs of acquisition, construction, reconstruction, enlargement, improvement, and equipping of city facilities, including site preparation involving dirt and utility work, stormwater improvements, and parking lot construction; security improvements to facilities city-wide; and converting the Grubb YMCA site into a City led Community Center, and that notice of the proposal to issue the Bonds and the right to petition for an election had been published as provided by Section 384.26 of the Code of Iowa, and the Mayor then asked the City Clerk whether any petition had been filed in the Clerk's Office, in the manner provided by Section 362.4 of the Code of Iowa, and the Clerk reported that no such petition had been filed, requesting that the question of issuing the Bonds be submitted to the qualified electors of the City.

WHEREAS, a public meeting was duly held at the time and place provided and in accordance with said notice, said meeting being reconvened to the date hereof, at which oral or written objections were received and filed, including the following:
