WHEREAS, on April 22, 2002, by Roll Call No. 02-992, the City Council of the City of Des Moines, Iowa voted to approve and accept from Polk County, Iowa, Form of Quit Claim Deeds for 2004 Leyner Street and 932 19th Place for the Martin Luther King, Jr. Parkway Project; and

WHEREAS, on July 28, 2008, by Roll Call No. 08-1309, the City Council of the City of Des Moines, Iowa voted to pass a resolution accepting and approving the Plat of Survey dedicating street right-of-way for the east/west and north/south segments of Martin Luther King, Jr. Parkway Project, and identifying the excess property for the Project; and
