WHEREAS, the Fire Department requested the Finance Department Procurement Division to issue purchase orders for the procurement of Extrication Tools to be used by the Fire Department; and

WHEREAS, Municipal Code section 2-726(d) provides for a non-competitive procurement of goods and/or services that are of such a nature that they are the only goods and/or services which will fit and comply with the required use, or are an integral part of a total system so as to be uniquely compatible with existing city needs, materials or equipment to be cost-effective; and

WHEREAS, the Procurement Administrator has determined that the various equipment required to complete the Extrication Tool kit are available from the following vendors, each of which are the sole area-wide distributor for the tools required:

A quantity of five (5) ResQJack vehicle stabilization tools and accessories procured from Sandry Fire Supply, 618 6th Street, Dewitt, IA 52742, Mary Sandry/Owner/Manager, in the amount of \$61,855.00,

A quantity of five (5) Vetter Emergency Rescue Air Actuated Equipment Set procured from Alex Air Apparatus, 11897 Co. Rd 87 SE, Alexandria, MN 56308, Vern Wieberdink Owner, in the amount of \$32,110.00,

A quantity of fifteen (15) various AMKUS Hydraulic Rescue Tools with additional accessories and annual training procured from Ed M. Feld Equipment Co., Inc (DBA: Feld Fire), 113 N. Griffin Rd., Carroll, IA 51401, John Feld Owner, in the amount of \$192,753.55,

WHEREAS, funding is available from C041FD99 544030 FR013 *Equipment Acquisition – Fire Department*, for a combined cost for Extrication Tools of \$286,718.55.

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the above described purchase of various Extrication Tools from Sandry Fire Supply, Alex Air Apparatus, and Ed M. Feld Equipment Co., Inc. for a total amount of \$286,718.55.
