### CONSENT AND ADDENDUM TO LICENSE AGREEMENT FOR SKYWALK SECURITY CAMERAS

#### WHEREAS:

• the undersigned LICENSOR is a party to a License Agreement providing, among other things, for the installation, operation, and maintenance of a system of security cameras in the Des Moines Skywalk, components of which will be located on property of the LICENSOR;

• the License Agreement provides that the LICENSOR must approve the plans and specifications of the system components that are to be installed on the LICENSOR's property prior to installation;

• all system components are to be installed and maintained in a good and workmanlike manner, in compliance with all applicable codes and ordinances, and with minimal disruption to LICENSOR's property and the use of the LICENSOR's property;

• some of the properties in which system components will be installed include the placement of the cameras themselves and those cameras, in order to operate, will require access/connection to electrical power from the electrical power system of the LICENSOR;

• the cameras will require a minimal amount of uninterrupted electrical power for operation;

• cable/wiring for the system installed in all of the various properties that have portions of the skywalk running through them will be appropriately labeled in order to distinguish that cable/wiring from other cable/wiring that may be located in proximity now or in the future;

• attached hereto is Exhibit A, which contains a schematic and plans and specifications for the portion of the security camera system that will be installed upon the LICENSOR's property.

THEREFORE, in consideration of the foregoing, the terms and provisions of the License Agreement, and other good and value consideration, the receipt and sufficiency of which are hereby acknowledged, it is agreed as follows:

1. The LICENSOR consents to the installation and maintenance of security camera system components in accordance with the foregoing and the attached Exhibit A.

2. As an Addendum to the License Agreement, the LICENSOR agrees that it will not voluntarily or intentionally disturb cable/wiring traversing any portion of LICENSOR's property while the License Agreement remains in force and effect.

3. As an Addendum to the License Agreement, each LICENSOR in whose property one or more cameras will be installed and maintained, agrees that the camera(s) can be connected

to the electrical system of the LICENSOR and the LICENSOR will not voluntarily or intentionally interrupt that electricity supply while the License Agreement remains in force and effect.

4. Except as modified or clarified by this CONSENT AND ADDENDUM, all other terms and conditions of the License Agreement remain in force and effect.



<u>Camera 1</u>



14' from ground




