APPROVING COMPLETION AND ACCEPTANCE OF THE PAVING IMPROVEMENTS SET FORTH IN AND CONSTRUCTED PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, GROVER WOODS PLAT 1, BETWEEN STERNQUIST CONSTRUCTION INC. AND HRC GROVER WOODS, LLC

WHEREAS, on June 22, 2020 under Roll Call No. 20-0979, the City Council approved a private construction contract in the amount of \$199,636.00, between Sternquist Construction Inc., Britt Sternquist, President, 1110 N. 14th Street, Indianola, IA, 50125 - as Contractor, and HRC Grover Woods, LLC, 6900 Westown Parkway, West Des Moines, IA - as Owner, for construction of paving Improvements described as paving improvements to serve Grover Woods Plat 1, as shown on Plan File Numbers 618-153/176, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.
