## SET HEARING FOR APPROVAL OF DOCUMENTS FOR CONVEYANCE OF VACATED CITY ALLEY RIGHT-OF-WAY LOCATED EAST OF AND ADJOINING 915 23<sup>RD</sup> STREET TO MARIA RODRIGUEZ FOR \$25

**WHEREAS**, on January 2, 1979, by Roll Call No. 6301, the City Council of the City of Des Moines, Iowa passed Ordinance No. 9517 vacating the alley right-of-way located south of Olive Street, north of Rollins Avenue and west of Woodland Cemetery, including that portion located east of and adjoining 915 23<sup>rd</sup> Street, Des Moines, Iowa; and

WHEREAS, Maria Rodriguez, owner of 915 23<sup>rd</sup> Street, has offered to the City of Des Moines ("City") the purchase price of \$25.00 for the purchase of the vacated north/south alley right-of-way located east of and adjoining 915 23<sup>rd</sup> Street (hereinafter "Property"), for assemblage with 915 23<sup>rd</sup> Street, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated, which price reflects the fair market value of the City Property as determined by the City's Real Estate Division; and

**WHEREAS**, there is no known current or future public need or benefit for the City Property proposed to be sold, and the City will not be inconvenienced by the sale of said Property.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, as follows:
