APPROVING SUPPLEMENTAL AGREEMENT NO. 1 TO THE PROFESSIONAL SERVICES AGREEMENT (PSA) WITH KIRKHAM MICHAEL & ASSOCIATES, INC. FOR DESIGN AND CONSTRUCTION SERVICES FOR HAMILTON DRAIN STORM WATER IMPROVEMENTS FOR CONSTRUCTION STAKING OF PHASE 2 AND FINAL DESIGN OF PHASE 3, NOT TO EXCEED \$430,000
