## ACCEPTANCE OF A PROPOSAL FROM MIDAMERICAN ENERGY COMPANY TO INSTALL NEW LED STREETLIGHTS FOR THE E. DOUGLAS AVENUE RECONSTRUCTION – E. 42<sup>ND</sup> STREET TO E. 56<sup>TH</sup> STREET, ESTIMATED AT \$255,147.96

WHEREAS, reconstruction of E. Douglas Avenue from E. 42<sup>nd</sup> Street to E. 56<sup>th</sup> Street requires installation of new street lighting; and


WHEREAS, MidAmerican Energy Company has submitted a proposal to the City to install 34 new LED streetlights on galvanized poles along E. Douglas Avenue between E. 42<sup>nd</sup> Street and Village Run Drive; and

WHEREAS, the proposal provides that MidAmerican Energy Company's estimated cost to install the streetlights is \$255,147.96, but is required by tariff to pay the actual costs of construction.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

- 1. That the proposal from MidAmerican Energy Company to the City of Des Moines for installation of street lighting on E. Douglas Avenue between E. 42<sup>nd</sup> Street and Village Run Drive, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content.
- 2. That the Mayor is hereby authorized and directed to accept and execute the proposal for and on behalf of the City of Des Moines, Iowa.
- 3. That the Engineering Department is authorized to administer the terms specified in the proposal.
- 4. That the Finance Director is authorized to make payment to MidAmerican Energy Company for upon receipt of an invoice acceptable to the Engineering Department.

Enclosed is our streetlight proposal for East Douglas Ave; WMIS: 2921331

This proposal includes the installation of streetlights on:

The estimated cost of this installation is **\$255,147.96**. Payment may be withheld until MidAmerican construction has been completed. Since the estimated cost of construction is over \$100,000.00, the City is required by tariff to pay actual costs upon completion of the work, which could result in additional charges to the City, or lesser charges than what has been estimated.

These lights will be installed on steel poles and served by underground conductors, but will be billed to the City at the wood pole, overhead rate because the City has agreed to pay the streetlight facilities charge.

MidAmerican Energy Company's streetlight proposal is based on the approved street light analysis provided by the City. MidAmerican Energy Company will install the lights based on the staked locations provided in the field by the City.

If this proposal meets with your approval, please sign and return one (1) copy of this letter and one (1) copy of the print.
