APPROVAL OF TERMINATION OF CHAPTER 28E AGREEMENT  
BETWEEN THE CITY OF DES MOINES AND  
THE DES MOINES RIVER FRONT DEVELOPMENT AUTHORITY  
FOR PLANNING, CONSTRUCTING AND MAINTAINING RIVERFRONT  
IMPROVEMENTS IN THE DOWNTOWN AREA

WHEREAS, on April 25, 2005, by Roll Call No. 05-1062, the City Council, pursuant to the City's authority under Iowa Code Chapter 28E, entered into an agreement with the Des Moines Riverfront Development Authority for the coordination of planning, construction, land use control, operation and maintenance of certain riverfront facilities and improvements in the downtown area ("28E Agreement"); and

WHEREAS, the 28E Agreement was recorded with the Polk County Recorder at Book 11040, Pages 437-454 and filed with the Secretary of State on April 29, 2005; and

WHEREAS, numerous facilities and improvements have been constructed along the Des Moines River riverfront since 2005 and are owned, operated and maintained by the City; and

WHEREAS, the term of the 28E Agreement is until April 29, 2025; and

WHEREAS, the Des Moines Riverfront Development Authority desires to terminate the 28E Agreement effective on November 15, 2021.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the Termination of Chapter 28E Agreement Between the City of Des Moines and the Des Moines Riverfront Development Authority For Planning, Constructing And Maintaining Riverfront Improvements In The Downtown Area, a copy of which is on file in the City Clerk's Office, be and is hereby approved and the Mayor is authorized and directed to sign said Termination Agreement on behalf of the City and the City Clerk is hereby directed to attest to said signature.

BE IT FURTHER RESOLVED that the City Clerk is directed to cause the executed Termination Agreement to be recorded and filed with the Secretary of State and shall send the Des Moines River Front Development Authority a copy with the recording and filing data shown.
