## SET HEARING FOR APPROVAL OF DOCUMENTS TO CORRECT THE VACATION OF THE NORTH-SOUTH ALLEY RIGHT-OF-WAY LOCATED WEST OF AND ADJOINING 1010 13<sup>TH</sup> STREET AND TO ISSUE A CORRECTED QUIT CLAIM DEED TO JOPPA CHEATOM PARK, LLC

**WHEREAS**, on October 18, 2021, by Roll Call No. 21-1585, the City Council of the City of Des Moines voted to pass Ordinance No. 16,055 vacating the north-south alley right-of-way located west of and adjoining 1010 13<sup>th</sup> Street, Des Moines, Iowa and to approve the sale of such vacated alley right-of-way to JOPPA Cheatom Park, LLC, for \$25.00, subject to the reservation of easements for any existing utilities until such time that they are abandoned; and

**WHEREAS**, subsequent to passing Ordinance No. 16,055 and recording a quit claim deed conveying said vacated alley right-of-way, an error was discovered in the legal description of the vacated alley right-of-way leading to the need to repeal said ordinance, pass a new ordinance to vacate the properly described right-of-way, and issue a Corrected Quit Claim Deed.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that:

1. The City Council of the City of Des Moines, Iowa, shall consider repealing Ordinance No. 16,055 and adopting a corrected ordinance permanently vacating the north-south alley right-of-way located west of and adjoining 1010 13<sup>th</sup> Street, legally described as follows, subject to the reservation of easements for any existing utilities until such time that they are abandoned:
