PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON EVERGREEN AVENUE REHABILITATION FROM MARION STREET TO S.E. 30TH COURT; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS GRIMES ASPHALT AND PAVING CORPORATION, TIMOTHY MALLICOAT, PRESIDENT, \$427,660.75

WHEREAS, on October 18, 2021, under Roll Call No. 21-1535, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

Evergreen Avenue Rehabilitation from Marion Street to S.E. 30th Court, 062019021

The improvement includes scarification, furnish and place Hot Mix Asphalt (HMA) pavement, Portland Cement Concrete (PCC) pavement, pavement removal, traffic control, seeding, and other incidental items; in accordance with the contract documents, including Plan File No. 635-001/034 located on Evergreen Avenue from Marion Street to S.E. 30th Court in Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

WHEREAS, in accordance with said notice, those interested in said proposed plans, specifications, form of contract documents, and Engineer's estimate of construction cost both for and against, have been given opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the upon due consideration of the facts, and any and all statements of interested persons, any objections to the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement are overruled and the hearing is closed and that said plans, specifications, form of contract documents, and Engineer's estimate of construction cost are here by approved.

BE IT FURTHER RESOLVED: That sealed bids for said improvement were submitted by the following bidders:

Ray Drive, Des Moines, Iowa at 11:00 a.m. on November 2, 2021. Said bids and the attached tabulation of bids for said improvement be and are hereby received and filed.
