### **CITY OF DES MOINES** SUPPLEMENTAL AGREEMENT NO. 1 TO AGREEMENT FOR PROFESSIONAL SERVICES

INDIANOLA AVENUE RECONSTRUCTION - ARMY POST ROAD TO U.S. HIGHWAY 69 Activity ID 01-2019-038

WHEREAS, on December 2, 2019, by Roll Call No. 19-1899, the City of Des Moines, Iowa, hereinafter referred to as the "City", and JEO Consulting Group, Inc. Robert S. Brigham, President, 142 W. 11th Street, Wahoo, NE 68066, hereinafter referred to as the "Consultant", entered into a Professional Services Agreement (the Agreement) in connection with the Indianola Avenue Reconstruction - Army Post Road to U.S. Highway 69, not to exceed \$395,810; and

WHEREAS, the City staff has negotiated a Supplemental Agreement No. 1 for additional professional services with the Consultant for additional utility coordination, design phase, survey and bidding phase services; and

NOW, THEREFORE, IT IS MUTUALLY AGREED, that the Agreement for Professional Services, Indianola Avenue Reconstruction - Army Post Road to U.S. Highway 69 is amended as follows:

SECTION 2 - SCOPE OF SERVICES, Paragraph A, SERVICES PROVIDED BY **CONSULTANT**, is amended by adding the following:

"Consultant shall provide additional utility coordination, survey, design and bidding phase services as set forth in Attachment 1 to this Supplemental Agreement."

**SECTION 3 – COMPENSATION, Paragraph A**, is amended by adding the following:

"Compensation for services under this Supplemental Agreement shall be in accordance with the terms of said original Professional Services Agreement for an additional not-to-exceed amount of \$62,020 to be paid on the basis of hourly labor rates and reimbursable costs.

**SECTION 4 – COMPLETION OF WORK**, is amended by adding the following:

"The Consultant shall complete all services outlined in Supplemental Agreement No. 1 on or before March 1, 2022, providing no unforeseen delays are experienced beyond the control of the Consultant."

BE IT FURTHER AGREED, that all other terms and conditions of the original December 2, 2019 Agreement shall remain in full effect except as modified by this Supplemental Agreement No. 1.

#### SCOPE OF SERVICES

## SUPPLEMENTAL AGREEMENT NO. 1 INDIANOLA AVENUE RECONSTRUCTION – ARMY POST ROAD TO U.S. HIGHWAY 69 ACTIVITY ID 01-2019-038 JEO PROJECT NO 190996.00

#### **GENERAL**

**CONSULTANT** shall provide additional utility coordination, design phase, survey, and bidding phase services to incorporate additional improvements requested by the **CITY** as noted below. The Scope of Services to be performed by the **CONSULTANT** shall include detailed work, services, material, equipment and supplies to complete the design of the roadway improvements.

#### A. UTILITY COORDINATION (ADDITIONAL SANITARY SEWER VIDEO)

The CONSULTANT shall provide additional sanitary sewer video services to account for an
unanticipated sag that was discovered in the sanitary sewer which prevented completion of the
initial video inspection of the sanitary sewer. To complete the video inspection of the sanitary
sewer, confined-space entry is required which is beyond the Scope of Services provided in the
original Agreement.

#### B. DESIGN PHASE SERVICES (US 69 HIGHWAY INTERSECTION IMPROVEMENTS)

- 1. The CONSULTANT shall provide design phase services for additional improvements at the intersection of Indianola Avenue and US Highway 69 including additional survey and design to account for through movement of Indianola Avenue at US Highway 69 including the design of dual, 150-foot long left-turn lanes with grading provisions to allow for future 350-foot long dual left turn lanes. Design shall also provide for necessary improvements within this intersection as well as the south leg of the intersection. Also included work required to obtain Iowa DOT Work in ROW permit.
- 2. Work required to complete and submit Traffic Control Device application necessary for signal timing revisions to the intersection of Indianola Avenue and US 69.

#### C. DESIGN PHASE SERVICES (ARMY POST ROAD INTERSECTION IMPROVEMENTS)

1. The **CONSULTANT** shall provide design phase services for additional improvements at the NW corner of the intersection of E. Army Post Road and Indianola Avenue. The additional services shall include additional survey and design of the trail and radius needed to account for the removal of the westbound Army Post Road acceleration lane. The additional services shall also include design for replacement of the eastbound Army Post Road right turn lane and removal of the eastbound Army Post Road acceleration lane.

#### D. DESIGN PHASE SERVICES (BLOOMFIELD ROAD IMPROVEMENTS)

1. The **CONSULTANT** shall provide design phase services to include the extended limits of reconstruction and realignment of Bloomfield Road from Indianola Avenue to Meadow Chase Lane, including the intersection of Meadow Chase Land and Bloomfield Road.

#### **E. SURVEY STAKING:**

The CONSULTANT shall provide survey staking services to for the following:

- 1. Layout of the proposed storm sewer location for informational purposes for the watermain relocation project being completed by Des Moines Water Works.
- 2. Layout of the proposed storm sewer location for informational purposes for the gas main relocation project being completed by MidAmerican Energy.

#### F. BIDDING PHASE SERVICES

The work tasks to be performed or coordinated by the **CONSULTANT** during the Bid Period Services are based upon one bid letting and shall include the following:

 Plan Clarification and Addenda: The bid letting shall be administered by the IDOT. The CONSULTANT shall assist the CITY during the bid periods in answering questions regarding the design intent. The CONSULTANT shall address questions presented by the IDOT and prepare addendum for distribution by the IDOT, if required.

#### G. CONSTRUCTION PHASE SERVICES

The work tasks to be performed or coordinated by the **CONSULTANT** during the Construction Phase Services shall include the following:

- 1. Pre-Construction Conference: The **CONSULTANT** shall attend/participate in a pre-construction conference with the Contractor, **CITY**, utility companies, affected entities and all interested parties to review the contract requirements, details of construction, utility conflicts and work schedule.
- 2. Shop Drawings The CONSULTANT shall review the Contractor's shop drawings, samples, and other required data for compliance with the contract documents. The CONSULTANT shall evaluate and determine the acceptability of substitute materials and equipment proposed by the Contractor and make a recommendation to the CITY regarding acceptance for the CITY's approval.
- 3. Design Interpretation Questions: The **CONSULTANT** shall provide answer to design interpretation questions from Engineer, Contractor, review agencies and utilities.
