## AUTHORIZING THE PURCHASE OF 4,905.50 STREAM MITIGATION CREDITS WITHIN THE DES MOINES RIVER MITIGATION BANK FROM THE CITY OF FORT DODGE, IOWA, FOR THE E. DOUGLAS AVENUE RECONSTRUCTION FROM E. 42<sup>nd</sup> STREET TO N.E. 56<sup>th</sup> STREET, IN THE AMOUNT OF \$245,275

WHEREAS, the E. Douglas Avenue Reconstruction - E. 42<sup>nd</sup> Street to N.E. 56<sup>th</sup> Street project will impact stream mitigation within the project area; and

WHEREAS, the United States Army Corps of Engineers has determined that 4,905.50 stream mitigation credits are required for the E. Douglas Avenue Reconstruction - E. 42<sup>nd</sup> Street to N.E. 56<sup>th</sup> Street project in accordance with Section 404 of the Clean Water Act; and

WHEREAS, the United States Army Corps of Engineers has approved the use of the Des Moines River Bank in the City of Fort Dodge for the stream mitigation required for the E. Douglas Avenue Reconstruction - E. 42<sup>nd</sup> Street to N.E. 56<sup>th</sup> Street project; and

WHEREAS, the City of Fort Dodge has approved the sale of 4,905.50 stream mitigation credits to the City of Des Moines, Iowa and is ready to provide the required credit upon a one-time payment of \$245,275.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the purchase of 4,905.50 stream mitigation credits from the City of Fort Dodge, Des Moines River Bank, at a total cost of \$245,275, is hereby authorized and the City Engineer is authorized and directed to take all necessary action to complete such purchase.
