APPROVAL OF RESOURCE ENHANCEMENT AND PROTECTION (REAP) GRANT AGREEMENT WITH IOWA DEPARTMENT OF NATURAL RESOURCES (IDNR)

WHEREAS, the Iowa Department of Natural Resources (IDNR) grant programs offer financial support to its local government partners for projects; and

WHEREAS, the City of Des Moines, through its Park and Recreation Department, applied for Resource Enhancement and Protection (REAP) Grant to help pay for the cost of woodland restoration project; and

WHEREAS, on September 13, 2021, by Roll Call No. 21-1423, the City Council ratified the grant application submitted by the Parks and Recreation Department to the Iowa Department of Natural Resources to seek Resource Enhancement and Protection (REAP) grant financial assistance in the amount of \$300,000; and

WHEREAS, the Beavertdale Park Woodland Restoration Project includes removal of invasive plant species, prescribed fire management, native seeding, removal of undesirable tree species, preservation of native key species, storm water management efforts such as constructed weir walls and stream bank armoring; and

WHEREAS, IDNR has notified the City that it has been awarded a grant for \$300,000 toward the cost of such project; and

WHEREAS, IDNR requires that the Resource Enhancement and Protection (REAP) Grant Agreement, a copy of which is on file in the City Clerk's Office, be executed by the City.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the Resource Enhancement and Protection (REAP) Grant Agreement for the above described grant in the amount of \$300,000, a copy of which is on file in the City Clerk's Office, is hereby approved and the Mayor is hereby authorized and directed to execute such Grant Agreement on behalf of the City.
