RESOLUTION AUTHORIZING THE REDEMPTION OF
OUTSTANDING SEWER REVENUE CAPITAL LOAN NOTES,
SERIES 2014B, OF THE CITY OF DES MOINES, STATE OF
IOWA, DATED APRIL 23, 2014, AND DIRECTING NOTICE
BE GIVEN

WHEREAS, the City did by Roll Call No. 14-0485 dated March 24, 2014, authorize the issuance of \$16,240,000 Sewer Revenue Capital Loan Notes, Series 2014B, (the "Notes") dated April 23, 2014; and

WHEREAS, the Notes are redeemable in any order of their numbering on June 1, 2022 or any date thereafter upon giving notice in the manner provided in the resolution authorizing the issuance of the Notes; and

WHEREAS, it is deemed necessary and advisable that \$1,175,000 be so redeemed on June 1, 2022 and notice of redemption be given according to the terms of the resolution authorizing issuance of the Notes.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, STATE OF IOWA:

Section 1. That outstanding Sewer Revenue Capital Loan Notes, dated April 23, 2014, in the principal amount of \$1,175,000, be and the same are hereby redeemed as of June 1, 2022.

Section 2. The Registrar and Paying Agent, City Treasurer of the Issuer, is hereby authorized and directed to cause written notice of such redemption be given not less than thirty (30) days prior to the redemption date and to cause notice of redemption to be provided to the registered owners of the Notes (DTC) in accordance with the Roll Call authorizing issuance.

Section 3. The Finance Director is hereby authorized and directed to cause to be deposited in a separate fund sum sufficient to pay all principal and interest on the redeemed Notes to the date of redemption and to notify the City's dissemination agent to post the Notice of Redemption to the MSRB's website (EMMA) in searchable PDF format for the refunded Notes in accordance with the Continuing Disclosure Certificate for the Notes.
