APPROVAL OF CERTIFICATION TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT OF THE AMENDED OPERATING BUDGET FOR ALL PROJECTS FOR FISCAL YEAR ENDING JUNE 30, 2022 AND OF THE PROPOSED OPERATING BUDGET FOR ALL PROJECTS FOR FISCAL YEAR ENDING JUNE 30, 2023

WHEREAS, on March 7, 2022, by Roll Call Nos. 22-0283 and 22-0284, the Municipal Housing Governing Board set the public hearings to consider the Municipal Housing Agency's amended annual budget for all projects for the current fiscal year ending June 30, 2022 and to consider the Municipal Housing Agency's proposed budget for all projects for the fiscal year ending June 30, 2023, for March 21, 2022 and public notice of such hearings was published as provided by law; and

WHEREAS, following the respective public hearings on March 21, 2022, the Municipal Housing Governing Board approved the Municipal Housing Agency's amendment to annual budget for all projects for the current fiscal year ending June 30, 2022, by Roll Call No. 22-0380 and approved the Municipal Housing Agency's proposed budget for all projects for the fiscal year ending June 30, 2023 by Roll Call No. 22-0381; and

WHEREAS, the Des Moines Municipal Housing Agency is required to certify approval of the operating budgets to the U.S. Department of Housing and Urban Development.

NOW, THEREFORE, BE IT RESOLVED by the Municipal Housing Governing Board that the Mayor and City Clerk, as appropriate, are hereby authorized and directed to certify the Municipal Housing Agency's amended annual budget for all projects for the fiscal year ending June 30, 2022 and to certify the Municipal Housing Agency's proposed budget for all projects for the fiscal year ending June 30, 2023 on the forms on file in the Office of the City Clerk and the Neighborhood Services Director is hereby directed to submit such certifications to the U.S. Department of Housing and Urban Development.
