APPROVING THE PURCHASE OF CISCO DNA SOFTWARE SUITES

WHEREAS, the Information Technology Department has requested the Finance Department's Procurement Division issue a purchase order for the purchase of Cisco DNA software suites for a use term of five (5) years pursuant to the Cisco Enterprise Agreement; and

WHEREAS, the Cisco DNA software suites, including support services, are being procured through the competitive bid process using the State of Iowa purchasing contract number 21306; and

WHEREAS, Municipal Code Section 2-726 (k) provides for the procurement of goods and/or services from supply schedules established by the State of Iowa Department of Administrative Services (DAS), without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the Cisco DNA software suites are being purchased from Heartland Business Systems (Peter Helander, President, 108 3rd St, Suite 300, Des Moines, IA 50309), in the total amount, covering the five-year duration of use, of \$594,813.61 utilizing the State of Iowa purchasing contract number 21306; and

WHEREAS, funding is available pursuant to CIP FY2020/21, MS001, C051IT99, Enhanced Information and Communication Systems, Page 33 in the amount of \$536,218.69 and CIP FY2020/2021, TR097, C038EG99, Traffic System Operation Improvement, Page 165 in the amount of \$58,594.92.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Des Moines, Iowa, approves the purchase of Cisco DNA software suites for a use term of five (5) years from Heartland Business Systems pursuant to the Cisco Enterprise Agreement in the total amount of \$594,813.61 using the State of Iowa purchasing contract number 21306, and the Information Technology Department Director is hereby authorized to approve and to sign any implementing or license agreements with Cisco Systems, Inc., subject to approval as to form by the Legal Department.
