ORDERING CONSTRUCTION OF
CITY-WIDE PAVEMENT MARKING PROGRAM
AND FIXING A DATE FOR RECEIVING OF BIDS ON APRIL 19, 2022
AND PUBLIC HEARING ON MAY 23, 2022
ENGINEER'S ESTIMATE IS \$265,000.00

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached communication recommending construction of the following improvement and the method of financing; and also including the recommendation of the Des Moines City Engineer, as the Engineer, submitting plans, specifications, form of contract documents, and Engineer's estimate of cost for the construction of the following improvement:

City-Wide Pavement Marking Program, 042022018

The project will include installing pavement markings, traffic control and other incidental items; all in accordance with the contract documents, including Plan File No 642-001/032 at the following locations in Des Moines, Iowa

- University Avenue from 25th Street to 31st Street
- Franklin Avenue from 48th Street to Merle Hay Road
- Euclid Avenue from 2nd Ave to 12th Street
- Oak Park Avenue from 6th Avenue to 11th Street
- 11th Street from Oak Park Avenue to Clinton Avenue
- Clinton Avenue from 6th Avenue to 11th Street

be and the same are hereby approved and accepted. The estimated construction cost for said improvement is \$265,000.00. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.

BE IT FURTHER RESOLVED: That this Council hereby determines that it is necessary and advisable to construct said improvement in the manner set forth in the plans, specifications, and form of contract documents submitted by the Engineer; and that payment for the cost of said improvement shall be paid from the funding source identified below.

BE IT FURTHER RESOLVED: That a public hearing on said plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be held in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, at 5:00 p.m. on May 23, 2022, at which time this Council will consider any objections offered thereto or to the making of said improvement.

BE IT FURTHER RESOLVED: That proposals will be received by the City of Des Moines, at the office of the Des Moines City Clerk until 11:00 a.m. on April 19, 2022, for the construction of said improvement, and the taking of bids in the manner required by law. Proposals received will be opened at a public meeting presided over by the Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, at 11:00 a.m. on April 19, 2022, after which the bids together with a bid tabulation and recommendation of the Engineer will be presented to the City Council at its next meeting for action thereon.
