RESCIND ACTION APPROVING PRIVATE CONSTRUCTION CONTRACT BETWEEN THE UNDERGROUND COMPANY, LTD. AND PINNACLE ON FLEUR, L.L.C. FOR SANITARY SEWER IMPROVEMENTS IN 2710 FLEUR DRIVE

WHEREAS, on September 14, 2020, by Roll Call No. 20-1420, the City Council approved a Private Construction Contract in the amount of \$73,814.00 between The Underground Company, Ltd., Duane Burkhardt, President, 12245 Dakota Street, Carlisle, IA, 50047 - as Contractor, and Pinnacle on Fleur, L.L.C., Bill Kimberley, President - as Owner, for construction of Sanitary Sewer Improvements described as Sanitary sewer improvements to serve the proposed Pinnacle on Fleur located at 2710 Fleur Drive as shown on Plan File Numbers 619-165/169, Activity ID 07-2021-102, and granted permission to the parties to construct said Sanitary Sewer Improvements; and

WHEREAS, Pinnacle on Fleur, L.L.C. desires to change the contractor for said improvements from The Underground Company, Ltd. (Duane Burkhardt, President, 12245 Dakota Street, Carlisle, Iowa — as Contractor), to a contractor to be determined at a later date, due to changes in the City’s plumbing regulations and the increase in the cost of materials; and

WHEREAS, The Underground Company, Ltd and Pinnacle on Fleur, L.L.C has requested that the City’s approval of the agreement be rescinded.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the City Council hereby rescinds its approval on September 14, 2020, by Roll Call No. 20-1420, to approve a Private Construction Contract in the amount \$73,814.00 between The Underground Company, Ltd., Duane Burkhardt, President, 12245 Dakota Street, Carlisle, IA, 50047 - as Contractor, and Pinnacle on Fleur, L.L.C., Bill Kimberley, President - as Owner; and directs the City Engineer to return all original contracts and bonds to Pinnacle on Fleur, LLC.


