APPROVING COMPLETION AND ACCEPTANCE OF THE PAVING, SANITARY SEWER, AND STORM SEWER IMPROVEMENTS SET FORTH IN AND CONSTRUCTED

PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, SE 2ND STREET BETWEEN E VINE STREET AND E ELM STREET AND E ELM STREET BETWEEN SE 3RD STREET AND SE 4TH STREET, BETWEEN RYAN COMPANIES US, INC. AND THE DISTRICT DEVELOPER, LLC

WHEREAS, on May 10, 2021 under Roll Call No. 21-0678, the City Council approved a private construction contract in the amount of \$2,796,584.00, between Ryan Companies US, Inc., Russell Lewton, Senior Vice President, 50 South Tenth Street, Suite 300, Minneapolis, MN, 55403 - as Contractor, and The District Developer, LLC, Paul D. Hayes, President, 512 ½ E Grand Avenue, Des Moines, IA, 50309 - as Owner, for construction of paving, sanitary sewer, and storm sewer Improvements described as Market District Phase 1A infrastructure including grading, storm sewer facilities, stormwater bioswales including concrete walls and cross beams, sanitary sewer facilities, and concrete street paving. Scope of work is inclusive of and defined as construction of SE 2nd Street between E Vine Street and E Elm Street and construction of E Elm Street between SE 3rd Street and SE 4th Street, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said paving, sanitary sewer, and storm sewer Improvements in the amount of \$2,796,584.00, which have been constructed in substantial compliance with the contract documents between Ryan Companies US, Inc.and The District Developer, LLC, which were approved under Roll Call No. 21-0678, dated May 10, 2021, be received and filed; and that completion of said paving, sanitary sewer, and storm sewer Improvements described as Market District Phase 1A infrastructure including grading, storm sewer facilities, stormwater bioswales including concrete walls and cross beams, sanitary sewer facilities, and concrete street paving. Scope of work is inclusive of and defined as construction of SE 2nd Street between E Vine Street and E Elm Street and construction of E Elm Street between SE 3rd Street and SE 4th Street, is hereby acknowledged and that said paving, sanitary sewer, and storm sewer Improvements are hereby accepted.
