**ACCEPTANCE OF A PROPOSAL FROM MIDAMERICAN ENERGY COMPANY
TO INSTALL NEW LED STREETLIGHTS FOR THE
E. DOUGLAS AVENUE RECONSTRUCTION – E. 42nd STREET TO E. 56th STREET,
ESTIMATED AT \$159,409.69**

WHEREAS, reconstruction of E. Douglas Avenue from E. 42nd Street to E. 56th Street requires installation of new street lighting; and

WHEREAS, MidAmerican Energy Company has submitted a proposal to the City to install 22 new LED streetlights on galvanized poles along E. Douglas Avenue between Village Run Drive and E. 56th Street; and

WHEREAS, the proposal provides that MidAmerican Energy Company’s estimated cost to install the streetlights is \$159,409.69, but is required by tariff to pay the actual costs of construction.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That the proposal from MidAmerican Energy Company to the City of Des Moines for installation of street lighting on E. Douglas Avenue between Village Run Drive and E. 56th Street, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content.
2. That the Mayor is hereby authorized and directed to accept and execute the proposal for and on behalf of the City of Des Moines, Iowa.
3. That the Engineering Department is authorized to administer the terms specified in the proposal.
4. That the Finance Director is authorized to make payment to MidAmerican Energy Company for upon receipt of an invoice acceptable to the Engineering Department.
