WHEREAS, the Police Department has requested the Finance Department's Procurement Division issue 2 purchase orders for the purchase of approximately 120 ballistic personal protective systems utilizing the NASPO ValuePoint Agreement number 164712, State of Iowa Master Agreement 21251 for the purchases from Galls and NASPO ValuePoint Agreement number 164720, State of Iowa Master Agreement 21235 for the purchases from Streichers; and

WHEREAS, Municipal Code section 2-726 (k) provides for the procurement of goods and/or services from contracts established by the State of Iowa Department of Administrative Services, the Iowa Department of Transportation, or the Iowa Communications Network pursuant to procedures established by Iowa Code Chapter 8A and rules and regulations promulgated thereunder; and

WHEREAS, the personal protective systems are being purchased from Galls LLC, 1340 Russell Cave Rd., Lexington, KY 40505 (R. Michael Andrews, CFO) and Streicher's Inc., 10911 W Highway 55, PO Box 41398, Minneapolis, MN 55441 (Jeremy Jenniges, President) in the amount of \$120,000; and

WHEREAS, funding is available from the general operating fund and the 2022 Byrne Justice Assistance Grant.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Des Moines, Iowa, accepts and approves the purchase of approximately 120 ballistic personal protective systems for the Police Department from Galls LLC and Streicher's Inc. in the amount of \$120,000, utilizing the NASPO ValuePoint Agreement number 164712, State of Iowa Master Agreement 21251 for the purchases from Galls and NASPO ValuePoint Agreement number 164720, State of Iowa Master Agreement 21235 for the purchases from Streichers.
