RESOLUTION APPROVING THE PURCHASE OF MAINTENANCE AND SUPPORT FOR HPE 3PAR STORAGE ARRAYS FROM ONENECK IT SOLUTIONS, AND APPROVING USE OF MINNESOTA WSCA-NASPO MASTER AGREEMENT NO. MNNVP-134 AND STATE OF IOWA CONTRACT # 16054, AND APPROVING AGREEMENT WITH HEWLETT PACKARD ENTERPRISE COMPANY

WHEREAS, the Information Technology Department has requested the Finance Department's Procurement Division to issue a purchase order for the purchase of Maintenance and Support for Hewlett Packard Enterprise 3PAR Storage Arrays; and

**WHEREAS**, said purchase is subject to Short Form Agreement No. K23-071 between the City and Hewlett Packard Enterprise Company, supplementing said State Contract, with terms specific to the City's procurement and in form on file in the office of the City Clerk as negotiated by the City's Finance and Information Technology Departments.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Des Moines, Iowa, that:

- 1. The purchase of Maintenance and Support for Hewlett Packard Enterprise Company (HPE) 3PAR Storage Arrays from OneNeck IT Solutions, in the total amount of \$62,150.40, and using the State Contract is hereby approved.
- 2. The Short-Form Agreement City Contract No. K23-071 between the City and Hewlett Packard Enterprise Company, in form on file in the office of the City Clerk, supplementing the State Contract with terms specific to the City's procurement, is hereby approved, and the Mayor is directed to execute said Agreement on behalf of the City following approval as to form by the Legal Department.
