RESOLUTION APPROVING FIRST AMENDMENT TO URBAN RENEWAL DEVELOPMENT AGREEMENT BY AND BETWEEN CITY OF DES MOINES, IOWA AND NATIONWIDE MUTUAL INSURANCE

WHEREAS, except as expressly amended in this First Amendment, the Agreement shall remain in full force and effect.

1. The proposed First Amendment to Urban Renewal Development Agreement By and Between City of Des Moines, Iowa, and Nationwide Mutual Insurance Company (Metro Center Urban Renewal Project) ("First Amendment"), is hereby approved, and the Mayor and City Clerk are hereby authorized and directed to execute such documents on behalf of the City.

2. The Finance Director is hereby directed to administer payments in accordance with all terms and conditions of the Agreement and the First Amendment.

3. The City Manager or the City Manager's designee is hereby authorized and directed to administer the First Amendment on behalf of the City.

4. The City Manager or his designee is directed to submit a copy of the fully executed First Amendment to the Finance Department to enable the Finance Director to make any appropriate disclosure filings in accordance with the City's Disclosure Policy.
