## HOLD HEARING FOR APPROVAL OF DOCUMENTS FOR CONVEYANCE OF EASEMENTS FOR UNDERGROUND ELECTRIC LINES IN PORTIONS OF GREENWOOD PARK TO MIDAMERICAN ENERGY COMPANY FOR \$17,505

**WHEREAS**, the City of Des Moines is the owner of certain parkland located in Greenwood Park, 4700 Grand Avenue, Des Moines, Iowa ("Property"); and

WHEREAS, MidAmerican Energy Company ("MEC") has requested permanent easements at the north end and at the south end of 45<sup>th</sup> Street, and along the eastern boundary of Greenwood Park in order to underground the existing overhead electric lines; and

WHEREAS, permanent easements are required only in those locations where the underground electric lines are outside of the existing 45<sup>th</sup> Street right-of-way; and

WHEREAS, there is no known current or future public need for the property interests proposed to be conveyed, and the City will not be inconvenienced by the conveyance of three Easements for Underground Electric Lines in the three portions of Greenwood Park; and

WHEREAS, on September 12, 2022 by Roll Call No. 22 · 1409, it was duly resolved by the City Council of the City of Des Moines, Iowa, that the proposed conveyance be set down for hearing on October 3, 2022, at 5:00 p.m., in the City Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa; and

WHEREAS, due notice of said proposal to convey the Easements was given to all necessary parties as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, as follows:

- 1. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed conveyance of three permanent Easements for Underground Electric Lines in three separate portions of Greenwood Park, as described herein, are hereby overruled and the hearing is closed.
- 2. There is no public need or benefit for the property interests proposed to be conveyed, and the public would not be inconvenienced by reason of the conveyance of three separate permanent Easements for Underground Electric Lines in portions of Greenwood Park, 4700 Grand Avenue, Des Moines, Iowa, as legally described, to MidAmerican Energy Company, for \$17,505.00 and said conveyance is hereby approved:

- 5. The Real Estate Division Manager is authorized and directed to forward the original of the Easements for Underground Electric Lines, together with a certified copy of this resolution and of the affidavit of publication of the notice of this hearing, to the Polk County Recorder's Office for the purpose of causing these documents to be recorded.
- 6. Upon receipt of the recorded documents back from the Polk County Recorder, the Real Estate Division Manager shall mail the original of the Easements for Underground Electric Lines and copies of the other documents to the Grantee.
- 7. Proceeds from the sale of these easements will be deposited into the Parks and Recreation Capital Projects fund C040, Park Infrastructure project PK175.
