RESOLUTION APPROVING THE PROCUREMENT OF UNIFORM AND ALTERATION SERVICES FOR THE POLICE DEPARTMENT FROM GALLS LLC AND APPROVING USE OF THE STATE OF IOWA MASTER AGREEMENT NUMBERS 21283, 22035, 22023 AND 22158

WHEREAS, the Police Department has requested the Finance Department Procurement Division to issue blanket purchase order for uniform and alteration services; and

WHEREAS, the Procurement Administrator has determined that clothing services are available from Galls, LLC, 1340 Russell Cave Road, Lexington, Kentucky 40505 (Michael Wessner, CEO), and have been competitively bid per State of Iowa Contract numbers 21283, 22035, 22023 and 22158; and

WHEREAS, the Contract #21283 is in effect until March 31, 2024, Contract #22035 is in effect until August 31, 2024, Contract #22023 is in effect until July 31, 2024 and Contract #22158 is in effect until December 31, 2024. The State of Iowa shall have the sole option to renew the contract with the same or more favorable terms and conditions for up to three annual extensions; and

WHEREAS, Municipal Code section 2-726 (k) provides for the procurement of goods and/or services from contracts established by the State of Iowa Department of Administrative Services, the Iowa Department of Transportation, or the Iowa Communications Network pursuant to procedures established by Iowa Code Chapter 8A and rules and regulations promulgated thereunder, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, funding is available from Police operating budget, page 191 of the Adopted Operating Budget, Department Detail for Fiscal Year Ending June 30, 2023.

NOW, THEREFORE, BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the purchase of uniform and alteration services during fiscal year 2023 from Galls LLC per State of Iowa Contract number listed above, at a total estimated annual cost of \$125,000.

BE IT FURTHER RESOLVED that the Procurement Administrator is authorized to issue purchase orders against the State of Iowa Contract with Galls LLC for the remaining term of the contracts ending as listed above. (Council Communication No. 22-5/4)
