RESOLUTION APPROVING THE PURCHASE OF FLYGT SUBMERSIBLE AXIAL FLOW PUMP AND STARTUP SERVICES FROM ELECTRIC PUMP, AND AUTHORIZING NEGOTIATION AND EXECUTION OF SUPPLEMENTAL AGREEMENT WITH ELECTRIC PUMP

WHEREAS, the Public Works Department, Sewers Division requested the Finance Department, Procurement Division to issue a purchase order in the amount of \$78,115.00 for the purchase of one Flygt brand submersible axial flow pump for the City's North Valley pump station; and

WHEREAS, the Procurement Administrator has determined that Flygt brand pumps and pump repair parts and services are available from Electric Pump, 4280 NE 14th Street, Des Moines, IA 50313, Tom Miller, President, the sole area-wide distributor; and

WHEREAS, Des Moines Municipal Code Section 2-726(c) provides for the non-competitive procurement of repair parts when the required parts are available only from a single area-wide distributor and competitive bids for such repairs are thus not prospectively attainable; and

WHEREAS, funding is available for the total cost of \$78,115.00 from Fiscal Year (FY) 2022-2023 Operating Budget, Public Works, PW247414 – 526030; and

WHEREAS, a Short Form Agreement between the City of Des Moines and Electric Pump with terms specific to the City's procurement may be required.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That the purchase of one Flygt brand submersible axial flow pump for the City's North Valley pump station from Electric Pump, at a total cost of \$78,115.00, is hereby accepted and approved.
2. To the extent determined necessary by the City of Des Moines Legal Department and Finance Department, the Finance Department is hereby authorized and directed to proceed with negotiation of a Short Form Agreement or similar agreement between the City and Electric Pump, and the City Manager is authorized and directed to execute said Agreement on behalf of the City of Des Moines following approval as to form by the Legal Department, which Agreement may be used for this and for future City procurement approved in accordance with City ordinance.
